
PRESIDENT'S MESSAGE



Khoe Tran joined ASMC in November 2020 when she learned about the Redstone/Huntsville Chapter from a colleague. Khoe initially joined ASMC to earn CPE hours, however, once she joined she became aware of the fellowship, various professional development events/conferences and received a warm and friendly welcome from fellow chapter members.

Since joining in 2020, Khoe has enjoyed volunteering at various community service events including Heroes Week and Panoply, just to name a few. Heroes week is held each year to honor veterans and those who



served in the military. In 2022, Khoe volunteered at the welcome table and helped distribute gifts to veterans, as well as provide information on the various events for the week. At the end of April 2023, Khoe volunteered at the Panoply Arts Festival at Big Spring Park where she helped 10-12 year olds perform science experiments. In addition to volunteering at ASMC events, Khoe also serves as a volunteer income tax preparer for a tax program sponsored by AARP Foundation and the IRS. Volunteering to prepare income tax returns is very rewarding. The program saved North Alabama taxpayers about \$950,000 in tax preparation fees for the tax season that just ended. If you don't know, the tax program is open to all income levels and age groups and utilizes tax software provided by the IRS.

Khoe Tran is a Certified Public Accountant (CPA). She started her financial management career as a DCAA Auditor then transitioned to U.S. Space and Missile Defense Command (SMDC) then Missile Defense Agency (MDA). Khoe worked as a Contract Price Analyst at MDA before retiring from the government. Shortly after retiring, Khoe became a contractor for different organizations. Now, Khoe works for BDO as a contractor performing quality control of cost estimates for United States Army Environmental Command (USAEC).

This course will principally cover Chapters 3, 5 and 6 of the GAO Redbook with particular emphasis on the three principal elements of Fiscal Law; the use of appropriated funds under 31 USC 1301 (Purpose Code), under 31 USC 1502 (Time Code/Bonafide Need), and 31 UCS 1341/1517 (Amount Codes/ADA).

The course will be supplemented with numerous case studies to reinforce the above principles of federal appropriations law.
