 - o Why is professional development and the pursuit of the CDFM certificate important to you?
- → Application Process/Deadline Essays must be submitted by 31 December to the member's local ASMC chapter. Each ASMC chapter president may submit one nomination.

What "Juneteenth" Means to Me

It's exciting to be able to express to everyone what Juneteenth means to me. It's especially exciting because I share a birthday with the Holiday. I didn't know the history of Juneteenth until about 15-20 years ago when I heard about a picnic in the park that a local Fraternity in the area had been celebrating for years. I became curious to find out what Juneteenth was all about and why there was a celebration for it. When I started my research, I was surprised to find out that this event was my actual birthday. So, I decided to dig in further and find out the meaning and purpose for Juneteenth. It was surprising to me that this was something we didn't learn about in school. Our history books only speak of the date January 1, 1863, the date the Emancipation Proclamation became law.

When I learned that Black people where still enslaved over 2 ½ years after the Emancipation Proclamation was issued it became important to me to educate my family, my children, and my friends. It surprises me today that a lot of people especially Black Americans, do not know the history around it. A few years back while walking the halls at work on my birthday, I was stopped by a co-worker because she wanted to read my birthday shirt. My shirt read, "Juneteenth Birthday Girl, Emancipation Day: 19 June 1865." My co-worker thought I had made "Juneteenth" up and she started laughing. I immediately shared the history of Juneteenth with her and she stated she had never heard of it. I told her how it's been celebrated in Texas and Louisiana for decades and how important it is for us to share this with everyone.

Do I believe Black people were made free and equal by the implementation of the Emancipation Proclamation? No, I don't. The Emancipation Proclamation only outlawed slavery within the rebellious states, but it DID NOT free Black people from Oppression. It DID NOT free us and create us equal in the eyes of the law. I could go on and on about this, but I'll stop here. I know America has a very long way to go to ensure that every single person in this country is afforded the same freedoms that are depicted within the Constitution of the United States as well as the Pledge of Allegiance but nationally recognizing Juneteenth as a federal holiday is one step in the right direction.

Awards/Scholarship – Committee Chair Tammara Buckey – Thank you Col Glover, Tina, and Debbie for the meeting yesterday. Sorry I couldn't attend as I had an obligation. I want to ask how the meeting went and if we have anything that we need to discuss to move forward for the awardees? COL Glover responded with presidential awards and dealing with scholarships, and we are fine with the 3 of the 4 that were selected. Debbie said that they were good with the information you and I discussed. Tammara then stated for everyone's awareness that we have 3 scholarship awards just like we advertised. Our budget has been plussed up based on the surplus of money we got from the Mini PDI so we will be doing \$2,000 for first place, \$1,000 for second place, and \$500 for third place winners. I am working on certificates and the letters to send out to the candidates and the guidance counselors.
