

increase or think about what you wanted to accomplish this year so we can vote on it at our next board meeting.

Financial Reports – Daphne Turner (Treasurer) – Keedra is the assistant treasurer. I've already told her that this year we should be able to get everybody else on the account. Last year there was a hiccup with the minutes, but the minutes are in, and I see it's on there. So Keedra should be able to be on there. And I don't know if you want to be on there or maybe Debbie, but at least one more person, the treasurer, the assistant, and then one more person. I'm going to need a signature to move the names over for the investment because I have not been able to get in there. But as soon as we're able to get those signatures and I can send it in, then I'll be able to update that part. Jeff Bacon stated "establishing budgets, and we need to go ahead and get out kind of the budget template. So probably want to start thinking about and figure out what they want to do this year so we can talk about it next board meeting and vote on it."

As of June, the balance is \$88,047.93. We had checks written in June totaling \$4,195. And I'll send this to everybody. There was a check written. Check. 1829 to Colonel Glover for the ASMC coins. Check. 1830 to Bowman's Enterprises for the Redstone Federal Credit Union. Plaque check written to me for \$60, for \$320. Gift cards from Starbucks for the recruitment winners, check 1832 to Redstone Federal Credit Union to the Atrium paying the luncheon bills. And apparently there was a bill from July of 2022 that we hadn't paid, so that had to be paid. Tamara Bucky gift cards, \$105. Scholarship recipient Jordan Farmer and the other scholarship recipient Briley Lake for \$500. That's where the \$4,195.95 came from. Then we had checks cleared of \$5,195. There is another check out. We had a deposit of \$349, and that's what gave us the 88 47.93. So as of right now, because I don't have a clear picture of the Morgan Stanley account, it's showing \$49,515. But as soon as I get that form signed and can get in there and see what's going on, I'll update all of the months, and then we'll have everything updated.
